#### Library report

The Summer Reading Challenge was a great success with a higher number of starters and completers than last year. We celebrated the end of the challenge with a sports themed party which was very well-attended and enjoyed by participants both young and old.

SCC have finally updated their New Volunteers Manual which has been distributed to all current volunteers electronically.

Our ability to take card payments has been welcomed by the public and by releasing cash through a card payment, it means the public without cash can now manage their accounts through the kiosk which is cash only.

SCC has trained several volunteers to waive or add charges to accounts. This procedure will be cascaded down to all volunteers in time.

The signage for Staff Parking which has been damaged/removed with be repaired/replaced by SCC. Non-library members continue to use the designated staff parking spaces ...and often for longer than the permitted time for the car park users.

An inventory of all equipment has been completed and submitted to SCC.

SCC has changed wifi providers. Access to wifi no longer requires a password and so is available to all library visitors.

Following on from the minutes of the last Ops Team, the public use of our toilet facilities has been discussed. FYI on the shift of 11<sup>th</sup> October a mother of a recently toilet-trained toddler asked to use the toilet (for the toddler). This was allowed but it was with some surprise that they were spotted accessing the staff area without permission a little later in the morning. On their exit from the area, the volunteer apologetically pointed out that non-public areas should not be accessed without permission. The mother, somewhat aggressively, retorted that her child was about to soil the library floor. Perhaps the code device on the door should be re-positioned to the foyer side?

The library OPS team is asking for advice from the council on handling this situation. Is there a possibility for public toilets in Bramley?
